ATG Issues Three Millionth Title Insurance Policy

In the midst of celebrating its 50th year, Attorneys' Title Guaranty Fund recently issued its three millionth policy.

ATG attorney-member Richard Fiocchi of Bernabei, Balestri & Fiocchi in Illinois issued the policy to William and Jill Thompson.

Founded in 1964 by a small group of downstate Illinois lawyers, ATG had issued one million policies by 1994 and two million by 2004.
